
## 1 Introduction

- 1.1 Pursuant to the agreement of the Parties, this arbitration is being coordinated with *The Renco Group, Inc. and Doe Run Resources Corp. v. Republic of Peru and Activos Mineros S.A.C.*, PCA Case No. 2019-47 (the “**Contract Case**”).
- 1.2 On 28 June 2021, the Respondent informed the Tribunal of the withdrawal of its external counsel. Consequently, the Respondent requested a revision to the procedural calendar.
- 1.3 On 12 July 2021, following further comments from the Parties, the Tribunal invited the Parties to discuss and attempt to agree upon a revised procedural calendar for this arbitration and the Contract Case once the Respondent had appointed new external counsel.
- 1.4 By joint e-mail of 22 September 2021, the Parties proposed a revised procedural calendar.

## 2 Procedural Calendar

- 2.1 The Tribunal hereby accepts and adopts the revised procedural calendar agreed by the Parties, as set forth in **Annex 1** to this Procedural Order.
