#### Procedural Order No. 17

#### I. BACKGROUND

- 1. On 2-3 October 2024, the Tribunal and the Parties held a hearing for the Parties' closing submissions.
- 2. On 8 October 2024, the Parties informed the Tribunal of their agreement to submit their corrections to the transcripts by 23 October 2024.
- 3. On 9 October 2024, the Parties informed the Tribunal of their agreement to submit their statements of costs by 11 November 2024.
- 4. On 14 October 2024, the Parties informed the Tribunal of their agreement to extend the deadline to submit their corrections to the transcripts by 29 October 2024.
- 5. On 29 October 2024, the Parties filed their corrections to the English and Spanish transcripts and informed the Tribunal of their disagreements regarding certain corrections to the transcripts.
- 6. On 9 November 2024, the Tribunal asked the Parties to provide certain clarifications regarding their proposed corrections to the transcripts, which the Parties filed on 13 November 2024. The Parties further informed the Tribunal of their agreement to submit their statements of costs by 15 November 2024.
- 7. On 15 November 2024, the Tribunal asked the Parties to clarify their position regarding one of their proposed corrections to the transcript, which the Parties did on the same day.
- 8. Also on 15 November 2024, the Parties filed their respective statements of costs.

### II. DECISION

9. The Tribunal adopts all of the Parties' agreed corrections to the English and Spanish transcripts.
