I. WHEREAS:

- 1. On July 25, 2025, the Tribunal issued Procedural Order No. 3, rejecting Respondent's Request for Bifurcation ("PO3").
- 2. In compliance with ¶ 49(ii) of PO3, on August 6, 2025, the Parties sent to the ICSID Secretariat a joint proposed procedural calendar for the phases of the proceedings following the Tribunal's decision on Respondent's Request for Bifurcation.
